The Cafe specializes in imaginative ethnic dishes at reasonable prices. Or try the Roche Harbor Inn which is noted for its ambiance and food!

Families traveling with children and the rest of us 'kids' might enjoy a trip to the Pacific Science Center and Children's Museum on Elliot Avenue. The Museum has lots of "hands on" activities for all ages. Or try a trip to the Woodland Park Zoological Gardens on Green Lake. I understand Green Lake has an excellent example of the local Eurasian Water Milfoil problem. A third option is a visit to Discovery Park which includes an arboretum and a fish ladder!

For those of you interested in nightlife, try the Pike Place Market or nearby Pioneer Square, both offer many dining and entertainment options. Pike Place is home to such treats as the Pike Place Brewery, a noted microbrewery, Jazz Alley, Comedy Underground, and Seattle Improv. # Proposed Changes to Bylaws

Article XVII of the Society's Bylaws requires that notice of proposed amendments to the Bylaws be given to the Secretary/Treasurer and transmitted to the membership thirty (30) days prior to the Annual Meeting. Several amendments are proposed by the Board of Directors for vote by the membership at this year's Annual Meeting. The following paragraphs explain the intentions of the Board of Directors in proposing these amendments to the membership.

First, amendments to the Bylaws are proposed to create separate offices of Secretary and Treasurer. To enact this change, the Board proposes amendments which include extensive modifications to Articles IV, V, VI, IX, XI, and XIII.

The Board of Directors also proposes changing official status of the outgoing President. Under current Bylaws, the outgoing President serves a oneyear period as "Director at Large" following the Presidential term, and as such remains a voting member of the Board of Directors for that time period. Because of the nature of the responsibilities assigned to this position in the Bylaws, the Board recommends establishment of the Office of Immediate Past President. The proposed amendments to accomplish this change include modifications to Article IV, Section A; Article IV, Section H; Article V; Article XI, Section B; Article XIII, Section A(10); and Article XIII, Section A(11).

Elimination of the Office of Newsletter Editor is proposed, with the duties previously assigned to that office being reassigned to the newly created Office of Secretary. This will require modifications to Article IV, Section A; and Article IV, Section E: elimination of old Section G under Article IV: removal of "Newsletter Editor" from Articles V and XI; and substitution of "Secretary" for "Newsletter Editor" in Article XIII, Section A(14).

The Board of Directors also proposes that the Bylaws be amended to eliminate all reference to gender. For this purpose, editorial changes are proposed to Article IV, Sections B, C, D, E, F; Article VI, Section A; Article XIII, Sections A, A(8), A(15), A(16), A(18); Article XVI, Sections A(1), A(2), A(3); and elimination of Article XVIII.

The Board further proposes amendments to the Bylaws that require both the Secretary and the Treasurer to make and execute a surety bond in an amount sufficient to equal the" total assets" of the Society. Current Bylaws require that the Secretary-Treasurer make and execute a surety bond in the amount of \$25,000.00, or in an amount specified by the Board of Directors. The Board further proposes that the Certified Public Accountant (CPA) who conducts the annual audit of the Society's financial records for the Treasurer be required to render an opinion as to the condition of said financial records. These changes are addressed by amendments to Article IV, Sections E and F.

Amendments to Article XIII are also proposed that will establish separate sections to differentiate among Standing Committees, Special Committees, and Special Representatives. Under current Bylaws, Special Committees and Representatives are included with the listing of Standing Committees.

The final proposed amendment to the Bylaws would require that the Board of Directors approve all proposed amendments before the amendments may be submitted to the membership for vote. Though the Society has been using this procedure in recent years, Board of Directors approval of amendments is not currently a requirement of the amendment process.

The proposed amendments necessary to achieve the stated changes described above constitute an extensive rewriting of the Society Bylaws. For those members who desire to examine the exact wording of these proposed amendments to the Bylaws prior to the membership vote, copies will be provided at the Registration Desk at the Annual Meeting, or members may request a copy by mail from the Secretary prior to the meeting.

### **1995 Scholarship Grant**

The South Carolina Aquatic Plant Management Society is seeking applications for its annual scholarship grant. If an appropriate applicant is found, the Society will award its fifth annual grant at its Annual Meeting in August 1995. The amount of the grant has increased to \$2000 for 1995. Grant funds may be used by the recipient to cover any costs associated with education and research activities.

Eligible applicants must be enrolled as full time undergraduate students in an accredited four year college or university in the United States. Coursework or research in the area of aquatic plant management or aquatic ecology related to the Southeast is also required.

Applications must be received no later than July 1, 1995 and will be evaluated on the basis of relevant test scores (ACT, SAT, GRE, etc.), high school and/or college grades, quality and relevance of research or coursework, a proposed budget, information obtained from references, and other related considerations. Other factors being equal, preference will be given to applicants enrolled in Southeastern and South Carolina academic institutions.

The successful applicant may be requested to present an oral report on research activities at the Society's Annual Meeting.

#### **1995 ANNUAL AUDIT**

As specified in the APMS bylaws, a complete audit was conducted in January 1995 of the APMS financial records. At the mid-winter Board meeting, the current status of all accounts (Operating, Operating Reserve Investment, Savings, Secretary, and Scholastic Endowment) was reviewed with the Board. All records are current, all accounts appear to have been appropriately allocated, and the Society's finances are healthy.
