Message from the **President, Carlton Layne**

Since I'm already elected, I think I'll forego that exercise and lay out some thoughts about the Society and the directions I'd like to take. I'm adopting part of the Hippocratic Oath to "First, Do no harm."

It may just be a coincidence that our financial markets have gone south just about the time that Immediate Past President Petta headed in that direction, but it does give one pause. For those who don't know, Jim Petta has accepted a posting with Syngenta Professional Products in Chile. He will be the Patron or Jefe of a new Syngenta farm that he is designing and building pretty much from scratch. Jim's presence will be missed at the aquatic meetings and I will miss his friendship very much. He thinks his Spanish is better than it really is, so there's no telling what crops will actually be planted and harvested there. His email address has remained the same so send him a message every now and then.

On a more serious note, financial issues are on everyone's mind these days. I'm sure APMS' investments will take a hit like everyone else's. We have enjoyed some pretty good meetings during the past few years thanks to the generosity and largess of our sponsors. Because of them our registration fees have remained relatively stable and we have thus been able to choose meeting sites and locations that present opportunities for some enjoyment outside the meeting halls and after the events of the day have ended. It would be imprudent for us to think that the Society and our benefactors will emerge unscathed by the scope of the nation's fiscal problems. That doesn't mean that we'll be meeting at the Motel 6 near the Atlanta airport next year, but we will have to tighten our financial belts and see what tomorrow brings.

I have appointed an *ad hoc* committee to (1) examine the society's financial circumstances to assure its soundness and (2) review our expenditures and make recommendations to the Board in regards to how to best conserve our resources and spend our money responsibly. Richard Hinterman will head that effort. The Board will consider his findings in January and implement recommendations as appropriate.

Secondly, I would like to see a closer working relationship with the various APMS Chapters. Our recent joint meetings have been very successful thanks in large measure to the tireless efforts of the host chapters. With our impending fiftieth anniversary we had to move quickly on the selection of a location for that meeting in Florida. We will meet in Milwaukee next summer and we'll meet in Bonita Springs, Florida in 2010. I can recall when we knew where our meeting locations were going to be for three years out. It turns out we can get some pretty good deals with the major hotel chains if we can guarantee meetings with them for three years regardless of where the meetings are located. It makes sense from both a fiscal and a chapter relationship standpoint to get back to the way we used to plan our meetings. With more time to plan the meetings and coordinate with the host chapter, our meetings, local arrangements and our respective relationships can only improve.

Lastly, there has been a lot of talk about the necessity – or not—of the APMS hiring an Executive Secretary or an Executive Director, or a meeting planner or some such critter to work for the Society. Dr. Greg MacDonald has been tasked with examining this question and bringing recommendations to the Board for consideration at the January meeting. We've been a volunteer organization since the beginning and as we've grown, we've become dependent on the charity of various organizations that have housed the Secretary, the Treasurer or both – such as the Lee County Water Hyacinth Control District, the Army Corps of Engineers, and various state and local agencies who may or may not have been aware of their contributions to APMS in terms of time, paper, computers, copiers and personnel. We are beginning to get an understanding of what the loss of that level of support can mean to the Society in both expenditures and logistical support. Thanks for all of your support and for tolerating me for so many years. I've never felt more comfortable than when I've been with a group of aquatic plant managers. Send me your ideas on how the Society can be improved from your perspective. I guarantee I'll consider all but the goofiest ones. I'm looking forward to seeing and talking with you at the next chapter meeting.

Hydrilla Observations in Kentucky

Four Kentucky reservoirs are presently known to have established populations of hydrilla. In 2000, hydrilla was observed in Paintsville Lake, in 2005 at Dewey Lake, and during 2006 at Kentucky Lake. Hydrilla was also found in Carr Creek Lake. Carr Creek, Dewey and Paintsville Lakes are in eastern Kentucky and Kentucky Lake is in western Kentucky.

The current degree of infestation of hydrilla at each reservoir varies. At Paintsville Lake (1,150 acres) hydrilla has spread throughout the

lake, but has remained close to shoreline areas due to the deep water depth. With consecutive dry summers in 2007 and 2008 and with zebra mussels significantly clearing the water, hydrilla has expanded dramatically in Dewey Lake (1,100 acres). The majority of Dewey Lake is < 20 ft depth and is heavily silted. Carr Creek Lake (710 acres) has hydrilla well established at one site to a depth of 15 feet. Carr Creek, Paintsville and Dewey Lakes are US Army Corps flood control reservoirs.

At Kentucky Lake, hydrilla was observed at a highly used public boat ramp in 2006. The rooted colony expanded to the small embayment at this ramp site, encompassing about 2 acres. However, Kentucky Lake is the last reservoir on the mainstem of the Tennessee River. Hydrilla has heavily infested Lake Guntersville in Tennessee, which is upstream of Kentucky Lake. In recent years, in the Tennessee portion of Kentucky Lake approximately 2,000 acres of hydrilla has been documented. Up until 2008, surveys for hydrilla have only revealed the dioecious variety of hydrilla in Kentucky Lake. The most recent survey by Tennessee Valley Authority biologists did reveal a small colony of monoecious hydrilla. So although hydrilla in Kentucky's portion of Kentucky Lake is just now showing up, there are larger colonies which have the potential to continue to spread downstream by fragmentation, seeds and boaters.

Biologists with Kentucky Department of Fish and Wildlife Resources are formulating plans of control and implementing public awareness measures. Materials for invasive species watch and stop aquatic hitchhikers are being released to the public. Signage will be constructed for placement at boat access ramps.

WAPMS Scholarship Announcement

The Western Aquatic Plant Management Society (WAPMS) is pleased to announce the 2009 Barbra H. Mullin Memorial Scholarship in the amount of \$1,000 to support students in the pursuit of a degree in aquatic sciences.

To be eligible, applicants must be currently 1) enrolled as a full-time undergraduate or graduate student in an accredited college or university in the western United States and 2) engaged in course work or research related to the biology, ecology, management, or education of aquatic plants. All scholarship applicants will receive a one-year membership to WAPMS and a waiver

of registration fees for the meeting in Honolulu, Hawaii March 29 to April 1, 2009.

Applications will be judged by a committee of academic, industry, and agency representatives. Judging will not be done by individuals with a personal or institutional affiliation with the applicant. Announcement of the scholarship winner will be made at the 2009 WAPMS meeting. Winner need not be present.

Application Procedure:

- 1. Applicant must provide a short resume/curriculum vitae, transcripts of college/university coursework (unofficial is acceptable), and a statement that describes the intended use of scholarship funds, applicable collaborators, and the applicant's career goals. The statement should be limited to four pages (double spaced).
- 2. Two letters of support must be presented. At least one should be from a college/university faculty member familiar with the applicant's abilities, interests and career goals. Letters may be emailed.
- 3. All application materials should be submitted electronically to the WAPMS Scholarship Program Chair, Toni Pennington (toni.pennington@tetratech.com), by February 20, 20009 at 5:00 (PCT).
